CAPC is laser-focused on three strategic goals in service of our vision—**Palliative Care Everywhere**. Explore the year in graphics to learn about our impact in 2023.







1M Visits to GetPalliativeCare.org

Relunched the national Palliative Care Provider Directory on GetPalliativeCare.org to help patients, families, and referring clinicians locate palliative care in their area. With more than 1 Million visits this year, GetPalliativeCare.org is one of the top sites for palliative care information for patients and families.



15 Comment Letters

Submitted 15 comment letters to federal agencies, with at least 3 acknowledgements in the final regulations.




3 Advisory Council Presentations

Published 9 journal articles and presented at 29 conferences and events.



The Palliative In Practice blog garnered 150,000 page views by 100,000 readers.




Catalyze Care Quality Improvement Beyond Specialty Palliative Care

Patients who need palliative care deserve it, full stop. But, we also have the opportunity to integrate palliative care principles and practices across all U.S. health care. We do this by training clinicians from all disciplines, specialties, and care settings in core palliative care skills. We are proud to have hit a major milestone this year: since the launch of our clinical training curriculum in 2015, **130,000 health care professionals** have completed more than **1.1 million CAPC courses**. This year alone, we achieved a record-breaking **200,000 course completions**.

4,900 Clinical Training Assignments

Launched a new clinical training hub for both clinicians and educators, including virtual games for clinicians to practice their skills. To date, 717 organizations have created more than 4,900 clinical training assignments.



Hosted the third national The John A. Hartford Foundation Tipping Point Challenge and the first NYC Tipping Point Challenge. Clinicians competed in two categories to enhance their clinical skills and catalyze innovation that will make positive, breakthrough change in the care of serious illness.



2,300 Designations

Developed a Learning Pathway to help prescribers meet the new DEA substance use disorder training requirement. 2,300 clinicians have completed this training and hold CAPC Designation.

6,000

Medical Students, Residents, and Fellows

Introduced new Learning Pathways to train nearly 6,000 medical students, residents, and fellows in palliative care skills.

730 Media Hits

Earned 730 media hits, with a print reach of 4.8 million, and publicity value of \$2 million. Highlights include mentions in ABC News, AP News, Fortune, Healio, Kaiser Health News Online, Philadelphia Inquirer, Verywell Health, The Grio, The New York Times, and The Washington Post.

500 Summit Attendees

Partnered with the Coalition to Transform Advanced Care (C-TAC) to present the first national C-TAC-CAPC Leadership Summit to 500 health care leaders and change agents, a sold-out event.

This year, we convened health equity champions, highlighted effective interventions to reduce disparities, and championed the needs of historically oppressed or underserved patients.


